# Terms of Reference for Consultant to carry out a small scale situational analysis on the professionalization of ECCD Facilitators and the need for professional development courses.

## 1. Background and rationale:

Early Childhood Care and Development (ECCD) is a critical stage in a child's overall development and learning. ECCD facilitators play a pivotal role in providing quality care and education to young children. Investing in ECCD facilitators' professionalization is essential for delivering high-quality early childhood care and education. By bolstering their skills and knowledge, the quality of ECCD programs can be elevated, positively influencing children's development during their formative years. This situational analysis highlight the current status and professional development of ECCD Facilitators to build the groundwork for improving the status of ECCD Facilitators and creating evidence-based professional development courses that cater to ECCD facilitators' professional requirements.

This terms of reference outlines the scope and objectives for a small-scale situational analysis focused on ECCD facilitators' professionalization and the necessity for professional development courses.

## 2. Purpose of the consultancy and scope of work

The primary objective of this situational analysis is to conduct an assessment of the current state of ECCD facilitators' professionalization and identify specific areas where professional development courses can enhance their skills and knowledge. This analysis will form the basis for designing targeted professional development programs to meet ECCD facilitators' identified needs.

## 3. Methodology:

The situational analysis will employ a mixed-methods approach, integrating the following methods.

• Literature Review:

Conduct a thorough review of existing literature, reports, and studies related to ECCD facilitators' professionalization and professional development courses. This review will provide insights into the current landscape, best practices and rationale for heightened status and improved professional development.

• Key Informant Interviews:

Conduct in-depth interviews with key stakeholders, including ECCD facilitators, trainers, policymakers, and field experts. These interviews will capture perspectives on challenges, training requirements, and potential opportunities for professional development.

## • Surveys and questionnaires:

Administer a survey and questionnaires to a representative sample of ECCD facilitators. Collect quantitative data on their educational backgrounds, received training, professional needs, and aspirations. This data will inform specific areas requiring professional development interventions.

• Current qualifications and Training:

Evaluate ECCD facilitators' educational qualifications and professional training to assess their readiness and competence. This will also help to identify the gaps in professional status, remunerations and limited access to professional development.

• Professional Development Recommendations:

Provide recommendations for professional development courses, including continuation of the existing mixed mode Diploma program, provision of a one-year Post Graduate Diploma in ECCD for university graduates to be recruited as ECCD teachers in the future, and bridging courses for diploma holders to advance their qualification and status.

## 4. Expected Outcomes:

The situational analysis will yield the following outcomes:

- A comprehensive understanding of ECCD facilitators' professionalization status, encompassing qualifications, training, and challenges.
- Identification of specific areas necessitating professional development, such as curriculum development, pedagogical approaches, inclusive education, child assessment techniques, and social-emotional development.
- Recommendations for designing and implementing targeted professional development programs such as the continuation of the mixed mode diploma for existing Facilitators without diploma, bridging courses for existing facilitators with diploma in ECCD and post graduate diploma for prospective ECCD teachers to be recruited in future.

## 5. Duty station

Will travel as required and as per the endorsed workplan and itinerary.

## 6. Supervisor

The consultant will work closely with the ECCD and SEN Division and report to MoESD (ECCD&SEND and PPD) and SCI, who will provide guidance and support throughout the project.
